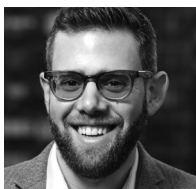

Meet the Artists



Steven Feifke

Steven Feifke is a Grammy-winning bandleader, composer, and arranger who has been featured on prominent news and television outlets including NBC, FOX, and CBS. His résumé includes collaborations with jazz icons Wynton Marsalis, Christian McBride, Christian Sands, and Veronica Swift as well as ensembles including the Metropole Orkest, Juilliard Jazz Orchestra, and Toronto Symphony. Feifke has extensively toured internationally including Thailand, Italy, Canada, Colombia, and Ecuador. His latest trio album *The Role of the Rhythm Section, Vol. II* captures the more intimate side of his artistry in a fresh take on

the classic piano trio. As a Yamaha Performing Artist and an Avid Sibelius Artist, Feifke has appeared on more than 45 albums to date. He has previously held a professorship of harmony and jazz composition at Berklee College of Music, and he has also been invited to give guest lectures and artist in residencies at institutions including Juilliard, Yale University, Jazz at Lincoln Center, New York University, UT Austin, and Northern Illinois University. In 2022, Feifke and his co-leader, trumpeter Bijon Watson, released *Generation Gap Jazz Orchestra*, an album with a mission of showcasing and celebrating generational diversity to strengthen the tradition of mentorship that has shaped and defined the jazz idiom since its beginnings. The album won a Grammy for best large jazz ensemble album; Feifke was the youngest winner in this category in Grammy history. In his free time, Feifke enjoys jogging, reading, and playing chess.

Juilliard Jazz Orchestra

The Grammy-nominated Juilliard Jazz Orchestra (JJO) performs music from the entire jazz continuum with fire and an understanding of the music's meaning and context. Composed of bachelor's and master's degree students, the orchestra appears on the stages of the Peter Jay Sharp Theater at Juilliard, Alice Tully Hall, Dizzy's Club, and other venues. It has performed with the Princeton and Albany symphonies and has been featured at the Jazz Educator Network's national conference. The JJO performs music by composers including Jelly Roll Morton and Bill Challis of the preswing era as well as works of the swing, bebop, and post-bop eras by composers including Mary Lou Williams, Duke Ellington, Eddie Durham, Tadd Dameron, Charles Mingus, and Ornette Coleman. The JJO also performs new works of alumni and students including Kyle Athayde, Joe Block, and Summer Camargo as well as contemporary composers including Wynton Marsalis, faculty member Ted Nash, Matt Wong, and Courtney Wright. Among the JJO's guest conductors are Scotty Barnhart of the Count Basie Orchestra, NEA Jazz Legend Jimmy Heath, José Madera, Jon Faddis, Jennifer Krupa (Artist Diploma '03, jazz trombone) of the Navy Commodores, Bill Charlap, Bill Dobbins, and members of the Jazz at Lincoln Center Orchestra. In recent years, faculty conductors have included Marsalis, Andy Farber, James Burton, Jerome Jennings, Michael Mossman, and Loren Schoenberg.
